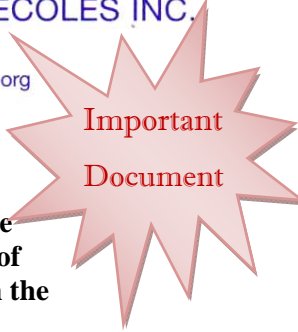

2. Prior to September 30<sup>th</sup> of the current year we will submit the Administration fee of \$50.
3. Beginning in September, *at the latest*, we will hold a membership campaign with the minimum goal to have 10% of our school families become members.
4. We will submit these memberships to the QFHSA office as they come in, with the understanding that to hold onto our members’ registration money is a breach of their trust and could jeopardize their insurance coverage and ours.
5. We will submit an activity report and a financial report to QFHSA at the end of June of this school year, or a month following our year-end.
6. We understand that it is our responsibility to try to send at least one voting delegate to the Annual General Meeting. If we are unable to do this, we will inform the QFHSA as to our reasons.
7. We also understand that it is to our benefit that our Executive members attend the leadership workshops, currently offered in September, and to have some members attend the Fall Conference.
8. We understand that these requirements are part of our role as a Home and School Association. They are responsibilities both to our members and to the Quebec Federation of Home and School Associations.
9. Furthermore, we understand that if we do not fulfill our obligations as stated, and are unable to offer a valid reason, the Quebec Federation of Home and School Associations has the authority to require us to close our bank account and to cease all activities as a Home and School Association.
